All horses to pay \$500 to enter and \$1,000 additional to start, with \$100,000 guaranteed, of which \$60,000 to first, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. 122 lbs. Non-winners of a Graded Stakes since April 26, 2013, allowed 3 lbs. Non-winners of a Graded Stakes since October 26, 2013, 5 lbs. Highweights preferred, followed by Graded Stake Winners, followed by Graded Stakes placed horses, followed by highest earners. Starters to be named through the entry box by the usual time of entries.
