**FrontRunner Stakes****Breeders' Cup "Win and You're In" Challenge Race****\$300,000 Guaranteed****(Grade I)**

**FOR TWO-YEAR-OLDS** By subscription of \$50 each if made on or before Saturday, August 26 or \$500 each if made on or before Thursday, September 21, 2017, or by supplementary nomination of \$6,000 at time of entry. All horses shall pay \$1,500 to enter, \$3,000 additional to start, with \$300,000 guaranteed. The winner to receive \$180,000 PLUS \$40,000 in Breeders' Cup entry fees PLUS 10 KY Derby points, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Weight 122 lbs. This race will not be divided. Graded Stake winners preferred, followed by Graded Placed horses, Stake winners, Total earnings in non-claiming races. The FrontRunner Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the FrontRunner Stakes will be entitled to automatic entry into the 2017 running of the Breeders' Cup Juvenile division. The nominated winner will also be entitled to have pre-entry and entry fees waived for the Breeders' Cup Juvenile or will receive a credit equal to the Breeders' Cup Juvenile pre-entry and entry fee and mount towards fees due for any other Breeders' Cup Championship race, and will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2017 Breeders' Cup Championships to be held at The Del Mar Thoroughbred Club on November 3 & 4, 2017, all horses must be pre-entered by NOON (PDT) at the designated pre-entry locations on Monday, October 23, 2017. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. Winning horse will be subject to out of competition testing by the California Horse Racing Board and and/or Breeders' Cup Limited and subject to the condition of entry regarding results of such testing. A trophy will be presented to the owner of the winner.
