Breeders' Cup "Win and You're In" Challenge Race

\$300,000 Guaranteed

FOR TWO-YEAR-OLDS By subscription of \$50 each if made on or before Saturday, August 23 or \$300 each if made on or before Thursday, September 18, 2014 or by supplementary nomination of \$6,000 at time of entry. All horses shall pay \$4,500 additional to start, with \$300,000 guaranteed. The winner to receive \$180,000 PLUS \$40,000 in Breeders' Cup entry fees PLUS 10 KY Derby points, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. 122 lbs. If this race oversubscribes, preference will be given in the following order: Graded Stakes winners, Graded Stakes placed, Stakes winners, total earnings at time of entry. The FrontRunner Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the FrontRunner Stakes will be entitled to automatic entry into the 2014 running of the Breeders' Cup Juvenile division. The nominated winner will be entitled to have pre-entry and entry fees waived for the Championship race, and will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2014 Breeders' Cup Championships to be held at Santa Anita Park on October 31 & November 1, 2014, all horses must be pre-entered by NOON (PDT) at the designated pre-entry locations on Monday, October 20, 2014. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. A trophy will be presented to the owner of the winner.
