FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD \$50 nominations close Thursday, September 26. \$2,000 supplementary nominations close at time of entry. \$1,500 to start with \$100,000 guaranteed; 60% to the winner, 20% to second, 12% to third, 6% to fourth and 2% to fifth. Three-Year-Olds: 123 lbs. Older 124 lbs. Non-winners of \$55,000 since April 15, allowed 2 lbs.; non-winners of \$50,000 in 2013, 4 lbs.; non-winners of a race other than Maiden, Claiming or Starter since July 15, 6 lbs. Highweights preferred, followed by Graded Stake Winners within 18 months of race, followed by Graded Stakes placed horses within 18 months of race, followed by highest earners within 12 months of race. Starters to be named through the entry box by the usual time of closing.
