



**2nd Running Of
Santa Anita Sprint Championship
Breeders' Cup "Win and You're In" Challenge Race
\$250,000 Guaranteed
(Grade I)**

FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$50 each if made on or before Saturday, August 24 or \$250 each if made on or before Thursday, September 26, 2013 or by supplementary nomination of \$5,000 at time of entry. All horses shall pay \$3,750 additional to start, with \$250,000 guaranteed. The winner to receive \$150,000 PLUS \$30,000 in Breeders' Cup entry fees, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. Three-Year-Olds: 123 lbs. Older: 124 lbs. Non-winners of a Grade I since April 5, 2013, allowed 3 lbs. Non-winners of a Grade I OR Two Grade II since October 5, 2012, 5 lbs. Highweights preferred, followed by Graded Stake Winners within 18 months of race, followed by Graded Stakes placed horses within 18 months of race, followed by highest earners within 12 months of race. The Santa Anita Sprint Championship has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Santa Anita Sprint Championship Stakes will be entitled to automatic entry into the 2013 running of the Breeders' Cup Sprint division. The nominated winner will be entitled to have pre-entry and entry fees waived for the Championship race, and will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2013 Breeders' Cup Championships to be held at Santa Anita Park on November 1 & 2, 2013, all horses must be pre-entered by NOON (PDT) at the designated pre-entry locations) on Monday, October 21, 2013. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. A trophy will be presented to the owner of the winner.
