Non-winners of a Graded Stake at One Mile or Over since April 24, 2 lbs.; Non-winners of a Graded Stake at One Mile Or Over, 4 lbs. Starters to be named through the entry box by the closing time of entries. High weights preferred, followed by Graded Stake winners, followed by Graded Stakes placed horses, followed by highest earners. Starters to be named through the entry box by the usual time of closings. A trophy will be presented to the winning owner.
