Non-winners of a Graded Stake at One Mile or Over since May 1, 2013, 2 lbs.; non-winners of a Graded Stake at One Mile Or Over, 4 lbs. Starters to be named through the entry box by the closing time of entries. This race will not be divided. Highweights preferred, followed by Graded Stake Winners, followed by Graded Stakes placed horses, followed by highest earners. Starters to be named through the entry box by the usual time of closings A trophy will be presented to the winning owner. The number following the name of horse represents a guide in determining the order of preference. Final preference will be determined at time of entry.
